By signing this application, you acknowledge that you are aware that the renters, as stated above are responsible for personal watercraft and any and all damages incurred during rental and agree to pay all damage of watercraft to Captain Matt's Boat Rental, LLC. in full.

Waiver Amendments:

- Captain Matt's Boat Rentals reserves the right to offer a rain check due to bad weather for prepaid rentals.
- Walk around of watercraft is always available upon request, if not requested you are giving up your right to dispute any damages to watercraft.
- You are responsible for damages incurred on the boat! If damages occur, your deposit will be held until the cost of damages is evaluated.
- Renter must be a minimum of 18 years old and have a valid Driver's License or be accompanied by an adult.
- Reservations are first booked, first served.
- Deposits are 50% of the scheduled session.
- Scheduled session is not valid until the deposit is on file.
- If a reservation is canceled up to 3 days in advance, the deposit amount can be applied at a later date within the same season. Within the 3 day period, the renter is responsible for the entire deposit amount and cannot reschedule.
- Health of Participant: The participant represents that he/she is in good physical health and does not suffer from any physical or mental conditions that may be adversely affected by boating activities.
- All rules are strictly enforced. An instructor or captain will go over the operations and rules of the watercraft with you before you leave the dock. Make sure you have a complete understanding of the rules and operations of the boat or personal watercraft before leaving the shore.
- No refunds unless personally authorized by the owner.
- I have read and fully understand the rules for operation of the watercraft and acknowledge by signing below. I agree to losses and expenses, including but not limited to any negligent, grossly negligent and/or intentional act, omission, or alleged design defect. This includes all third party incidents including minor children under undersigned's custody, care and control. Captain Matt's Boat Rental, LLC. is not liable for any personal injury, property or any damage to other watercraft while renting from this establishment.
- By signing this waiver, you are acknowledging that you have not been exposed to anyone with Covid-19 in the past 14 days, and are showing no symptoms, Symptoms including: Fever or chills, Cough, Shortness of breath or difficulty breathing, Fatigue, Muscle or body aches, Headache, New loss of taste or smell, Sore throat, Congestion or runny nose, Nausea or vomiting.
